

Castle Crocs Swim Team 2010 Family Agreement

We, the proud parents of a Castle Crocs swimmer, understand and agree with the following important policies of the Castle Crocs Swim Team:

- 1) Each week that a meet is scheduled, all parents or swimmers must let the coach know by Tuesday evening (at the latest) if their swimmer(s) will be attending the next Saturday's Meet.**
- 2) It is a pool policy, and our policy, that any child under the age of 13 years old must be accompanied by an adult at all meets.** The Castle Crocs Swim Team is not responsible for your children if left unattended at the pool for any reason. If you leave your child/children unattended, it could jeopardize not only their position on the team, but more importantly, their safety.
- 3) All swim teams rely on the parents to run the swim meets. Each family is required to fulfill volunteer requirements in order for their swimmers to participate. Families that are unable to volunteer at swim meets may "opt out" by indicating below and paying the "opt out fee" of \$250.**

- 4) All swimmers must be able to swim one length of the pool without grabbing the ropes, side of the pool or touching the bottom on their first day of practice. If a child cannot do this, we cannot allow them to be on the team for safety purposes. We will refund your money and look forward to seeing you next year.**
- 5) All families and swimmers should act in the spirit of friendship and good sportsmanship at both practice and meets. Unsportsmanlike conduct will not be tolerated.**
- 6) If for any reason you are not able to participate after joining the team, we are happy to refund your money provided we are notified by June 15th. A \$25 charge will be deducted to cover processing and fees paid to the MHSL which are non refundable.**
